How to Find CIARUS

- **From the airport:** a shuttle bus will take you from Entzheim airport to the “Baggersee” tram station. From there, take line A to HautePierre and get off at “Place des Halles”
- **From the autoroute, by car:** from the North (Metz-Paris), take exit “Strasbourg centre – Avenue des Vosges” and follow the signboards to “Ciarus”, from the South (Colmar-Mulhouse), take exit “Wacken” to “Avenue des Vosges” and follow the signboards to “Ciarus”.
